INVITATION TO BID

PROPOSED REPAIR/REHABILITATION OF ORETA, VICENCIO AND SANDOVAL SCHOOL BUILDINGS AND UPGRADING OF ELECTRICAL SERVICE ENTRANCE AT CITY OF MALABON UNIVERSITY (CMU), LOCATED AT MAYA-MAYA ST., KAUNLARAN VILLAGE, BRGY. LONGOS, CITY OF MALABON

1. The *City Government of Malabon*, through the *CMU MOOE CY 2014* intends to apply the sum of **One Million Ninety-Six Thousand Six Hundred Eighty-Nine Pesos and Seven Centavos (P1,096,689.07)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Repair/Rehabilitation of Oreta, Vicencio and Sandoval School Buildings and Upgrading of Electrical Service Entrance at City of Malabon University (CMU), located at Maya-Maya St., Kaunlaran Village, Brgy. Longos, City of Malabon. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Malabon* now invites bids for the Proposed Repair/Rehabilitation of Oreta, Vicencio and Sandoval School Buildings and Upgrading of Electrical Service Entrance at City of Malabon University (CMU), located at Maya-Maya St., Kaunlaran Village, Brgy. Longos, City of Malabon. Completion of the Works is required within forty-five (45) days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee in the amount of **Five Thousand Pesos (P5,000.00)**.
6. The *City Government of Malabon* will hold a Pre-bid Conference on **June 27, 2014 (Friday); 2:30 p.m.** at the BAC Secretariat Office, Malabon City Hall, F. Sevilla Blvd., Malabon City, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **July 10, 2014 (Thursday); 2:00 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms set in the amount stated in ITB Clause 18. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below on **July 10, 2014 (Thursday); 2:30 p.m.** Late Bids shall not be accepted.
8. The *City Government of Malabon* reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
