Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The *City Government of Malabon* now invites bids for the Supply and Delivery of Various Vehicles for Malabon Disaster Risk Reduction Management Office. Delivery of goods is required thirty (30) calendar days after the receipt of Purchase Order (PO). The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183 and subject to Commonwealth Act 138.
